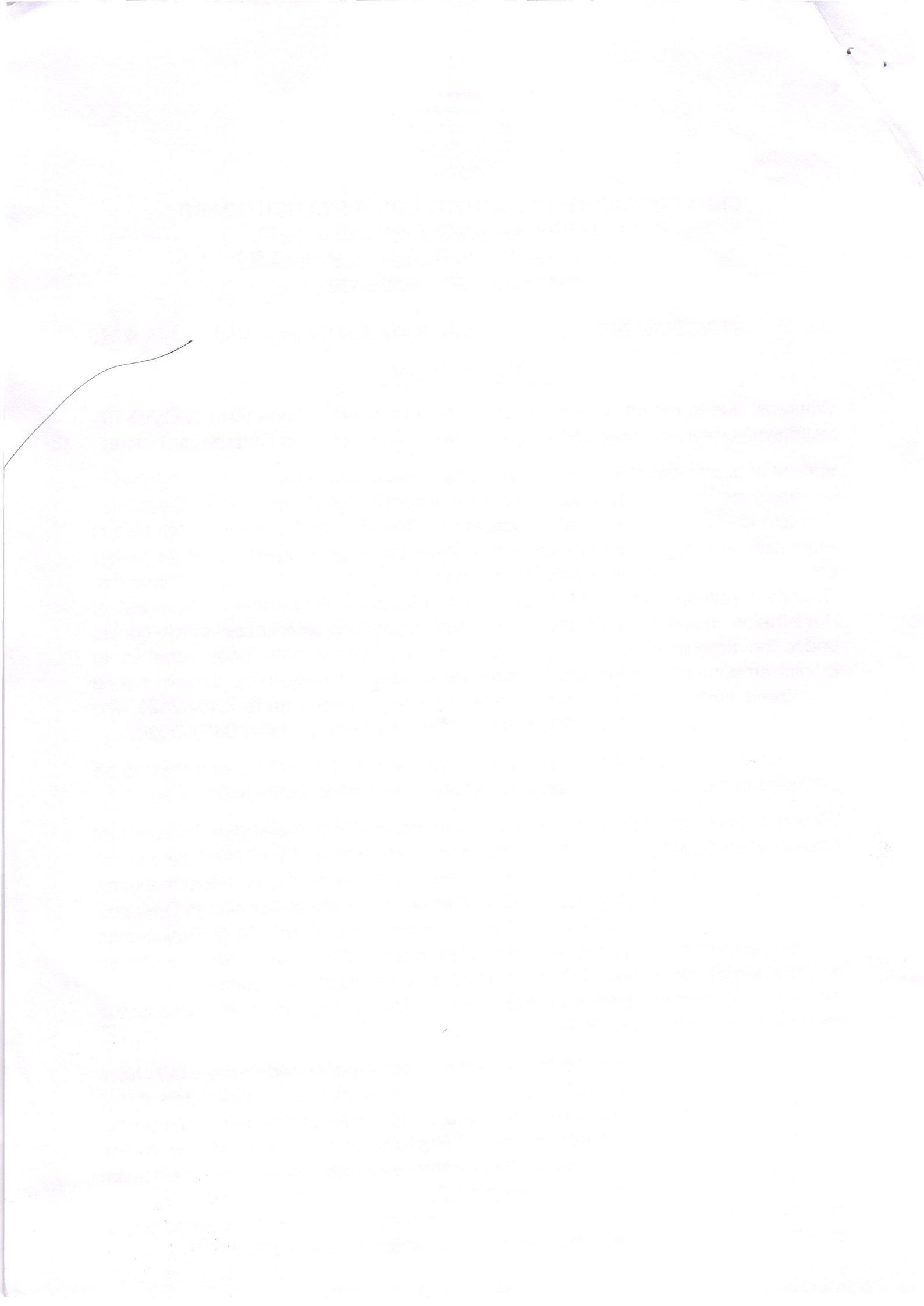
Whereas; due to recent outbreak of the pandemic Novel Corona Virus (COVID-19), lockdown/curfew has been imposed in whole country including Chhattisgarh State.

In view of above situation of lockdown/curfew; those which have already applied or will apply as per existing rules / order for extension of Permission to Establish / Consent to Operate / Renewal of Consent to Operate / Authorization / Renewal of Authorization / Registration / Renewal of Registration granted by Board for further period, the Permission to Establish / Consent to Operate / Renewal of Consent to Operate / Authorization / Renewal of Authorization / Registration / Renewal of Registration including any other mandatory regulatory clearances which comes under the domain of Chhattisgarh Environment Conservation Board granted to project proponents / industries / institutions expired or likely to be expired during lockdown/curfew period as the case may be, was extended up to 30/04/2020 vide office order no. 01/TS/CECB/ 2020, Nava Raipur Atal Nagar, dated 06/04/2020.

Whereas, the lockdown period has been extended upto 03/05/2020 and likely to be extended and/or opened with certain strict restrictions after 03/05/2020.

Whereas, a number of applications have been received in Chhattisgarh Environment Conservation Board with respect to above and processing of individual case is not being possible for timely disposal before 01/05/2020. Hence, it is pertinent to extend the Permission to Establish / Consent to Operate / Renewal of Consent to Operate / Authorization / Renewal of Authorization / Registration / Renewal of Registration including any other mandatory regulatory clearances which comes under the domain of Chhattisgarh Environment Conservation Board granted to project proponents / industries / institutions expired or likely to be expired during lockdown period as the case may be, for further period.

In view of above situation of lockdown; for all above mentioned cases which have already applied or will be applied as per rule / order during lockdown period, the Permission to Establish / Consent to Operate / Renewal of Consent to Operate / Authorization / Renewal of Authorization / Registration / Renewal of Registration including any other mandatory regulatory clearances which comes under the domain of Chhattisgarh Environment Conservation Board granted to project proponents / industries / institutions expired or likely to be expired during lockdown period and/or after 30/04/2020 as the case may be, is hereby extended up to 31/05/2020.



The other terms and condition mentioned in office order no. 01/TS/CECB/ 2020, Nava Raipur Atal Nagar, dated 06/04/2020 shall remain unchanged and effective.

This order will come into force with immediate effect.


