:- Office Order :-

Whereas, Chhattisgarh Environment Conservation Board has granted "Permission to Establish", "Consent to Operate" and "Renewal of Consent to Operate" under section 25 of the Water (Prevention and Control of Pollution) Act, 1974 and/or under section 21 of the Air (Prevention and Control of Pollution) Act, 1981 for specific period mentioned in the respective letters.

Whereas, Chhattisgarh Environment Conservation Board has granted "Authorization" and "Renewal of Authorization" under rule 6 of the Hazardous and Other Waste (Management and Transboundary Movement) Rules, 2016 and/or under rule 10 of the Biomedical Waste (Management and Handling) Rules, 2016 for specific period mentioned in the respective letters.

Whereas, Chhattisgarh Environment Conservation Board has also granted "Registration" and "Renewal of Registration" under rule 13 of Plastic Waste management Rules, 2016 for specific period mentioned in the respective letters.

Whereas; due to recent outbreak of the pandemic Novel Corona Virus (COVID-19), lockdown/curfew has been imposed in whole country including Chhattisgarh State.

Whereas; in some cases, Permission to Establish / Consent to Operate / Renewal of Consent to Operate / Authorization / Renewal of Authorization / Registration / Renewal of Registration granted by Chhattisgarh Environment Conservation Board may have expired in the month of March 2020 or may expire during the lockdown/curfew period.

Whereas; project proponents / industries / institutions have already applied as per existing rules / order for extension of Permission to Establish / Consent to Operate / Renewal of Consent to Operate / Authorization / Renewal of Authorization / Registration / Renewal of Registration granted by Board for further period to Chhattisgarh Environment Conservation Board and are under consideration.

Whereas; project proponents / industries / institutions will also apply as per existing rules / order for extension of Permission to Establish / Consent to Operate / Renewal of Consent to Operate / Authorization / Renewal of Authorization / Registration / Renewal of Registration granted by Board for further period to Chhattisgarh Environment Conservation Board during lockdown/curfew period.

Whereas; in the situation of above mentioned lockdown/curfew period, the processing of individual cases, which have already applied for extension of Permission to Establish / Consent to Operate / Renewal of Consent to Operate / Authorization / Renewal of Authorization / Registration / Renewal of Registration for further period, by Chhattisgarh Environment Conservation Board is not being possible. Similarly, the processing of those individual cases, which will be applied as per rule / order during lockdown/curfew period will also be not possible.

In view of above situation of lockdown/curfew; for all above mentioned cases which have already applied or will be applied as per rule / order during lockdown/curfew period, the Permission to Establish / Consent to Operate / Renewal of Consent to Operate / Authorization / Renewal of Authorization / Registration / Renewal of Registration including any other mandatory regulatory clearances which comes under the domain of Chhattisgarh Environment Conservation Board granted to project proponents / industries / institutions expired or likely to be expired during lockdown/curfew period as the case may be, is hereby extended up to 30/04/2020.

This order shall be applicable for all above mentioned cases of Permission to Establish / Consent to Operate / Renewal of Consent to Operate / Authorization / Renewal of Authorization / Registration / Renewal of Registration granted by Member Secretary, Chhattisgarh Environment Conservation Board and /or respective Regional Officer, Chhattisgarh Environment Conservation Board.

The above order for extension of validity up to 30/04/2020 shall not be applicable to extension of Permission to Establish of such activities / industries which have already been banned in certain areas by any order of State Government / Chhattisgarh Environment Conservation Board or shall not be applicable to extension of Permission to Establish of activities / industries in Critically Polluted Area.

This order will come into force with immediate effect.
