Subject: Regarding exemption from annual routine inspection to medium risk / orange category industries on submission of Third Party Certification from Board Recognized Inspection Agencies


Central Pollution Control Board has classified industries into Red, Orange and Green category considering pollution generated from industries. As per the above classification, the prevalent policy is of inspecting medium risk / orange category industrial units at periodic intervals of time.

Without compromising matters on environment and in continuation of Office Order no. 5734/TS/CECB/2016, Dated 24/02/2016, to facilitate industrial units as part of ongoing Ease of Doing Business (EoDB) exercise and also for better public administration, it has now been decided that such medium risk / orange category industries, may be exempted from annual routine inspection, if they submit compliance report in prescribed format with-self certification, after inspection through Board recognized third-party.

In special cases such as complaint against the industrial unit and/or court case and/or in case where Board feels necessary, such exemption will not be applicable and competent officer of the Board shall decide and inspect the industrial unit.

Above referred third party certification has to be obtained by Board's recognized inspection agencies. Moreover, if in any case any discrepancy is found in the certificate issued by the agency, then in such cases, this matter will be brought to the notice of Board through concerned unit head & after proper verification by the Board, steps like short-term de-recognition, long-term de-recognition, permanent de-recognition, black listing of third-party inspecting agency and any other legal remedies available in law, shall be taken against the defaulting agency.


